#### SUMMARY ANNUAL REPORT

#### ROOFERS LOCAL NO.74/NO. 203 WELFARE FUND

This is a summary of the annual report for the Roofers Local No. 74/No. 203 Welfare Trust Fund, EIN 16-0836163, Plan No. 501 for the period July 1, 2017 to June 30, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Insurance Information**

The Plan has a contract with The Union Labor Life Insurance Company to provide stop-loss insurance for claims incurred under the terms of the Plan. Total premiums paid during the Plan year were \$109,721.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$8,810,111 as of June 30, 2018 compared to \$9,656,915 as of July 1, 2017. During the plan year the plan experienced a decrease in its net assets of (\$846,804). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$3,880,821. This income included employer contributions of \$3,108,505, participant contributions of \$79,243, realized losses of (\$56,945) from the sale of assets, earnings from investments of \$612,503, prescription drug rebates of \$127,207, and other income of \$10,308.

Plan expenses were \$4,727,625. These expenses included \$447,343 in administrative expenses, \$4,280,282 in benefits paid to participants and beneficiaries, and premiums paid to the insurance carrier for stop-loss insurance coverage.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.
